## PLAN DETAILS – BCBS Preferred Blue PPO With Benemax

The Benemax Health Plan<sup>®</sup> integrates a fully insured component from Blue Cross Blue Shield of Massachusetts (BCBS) and an employer-funded component from Borden & Remington into a single benefit package. The BCBS plan has an annual deductible of \$3,000 per member (\$7,500 family maximum). Borden & Remington, via Benemax, pays the plan deductible on your behalf, less applicable co-pays. In addition, the co-insurance and co-pays due after the BCBS deductible is met are also supplemented.

Below is a brief reference of frequently used services and your final cost after your claims have been processed by both BCBS and Benemax.

**Out-of-Network:** If you go to an out-of-network provider, your provider may ask you to pay the full charge for services at the time of your visit. Office visits, when they fall within the first \$2,000/year of approved charges, cost \$15. After that in-and out-of-network deductible is met, an additional deductible of \$3,000 applies and co-insurance of 20% to 40% is member responsibility. All charges considered over usual, and customary are member responsibility.


